The personal data contained in the e-mails you send in response to this e-mail are collected through the Outlook system and processed on the basis of the following legal grounds under Article 5 of the Law on the Protection of Personal Data No. 6698 (“Law”):

- Article 5/2-e: “Where processing of data is necessary for the establishment, exercise, or protection of a right”
- Article 5/2-f: “Where processing of data is necessary for the legitimate interests of the Data Controller, provided that it does not prejudice the fundamental rights and freedoms of the data subject.”

It is deemed that the personal data you provide to Toros Terminal have been lawfully obtained and that you have taken the necessary technical and organizational measures in relation to such data.

The personal data obtained in this manner may be transferred to Toros Terminal’s affiliates, subsidiaries, business partners, suppliers, and customers, in line with the purpose of the relationship between the parties and in accordance with Article 8 of the Law.

Transfer Abroad

Our e-mail service infrastructure is provided by Microsoft Corporation, which may involve the transfer of your personal data abroad. Tekfen Holding A.Ş., the e-mail service provider of Toros Terminal, has executed Standard Contractual Clauses (SCCs) with Microsoft Corporation within the scope of Appropriate Safeguards. These SCCs provide the necessary legal assurance for the transfer of personal data abroad in compliance with Article 9 of the Law.

The SCCs, as announced by the Turkish Personal Data Protection Board, include provisions on categories of personal data, purposes of data transfers, recipients and categories of recipients, technical and organizational measures to be taken by the data importer, and additional measures for special categories of personal data.
